

2013 City Council Activity Report

City of Albion, Nebraska

A monthly summary of notable policy and legislative action taken by the Albion City Council during the year 2013.

Notable 2013 Operations Activities for the City of Albion:

- ❖ Pool Committee met several times to review pool site plan and design details;
- The Pool Committee established a Capital Campaign to raise funds for the pool, setting and surpassing a \$450,000 fundraising goal;
- The City was awarded a \$100,000 Challenge Grant from the Peter Kiewit Foundation for the Pool Project;
- Installed EV Charging Station at White Star as part of a grant to being establishing charging network across the state;
- Several meetings were held regarding the punch list for the Water Well Project, little progress made in 2013;
- VFD issues resolved at the new well in late 2013;
- Scheduled installation for the stainless steel shaft at the new well for early January 2014;
- Water department reported progress in radio-read meter change-out program;
- Utility Billing surpassed the goal of 180 patrons utilizing the ACH automatic withdrawal payment option;
- Micro-surfacing street maintenance project completed on Downtown Asphalt Streets as well as a portion of 6th Street by the school;
- Street patch and maintenance project completed including Park Street between 6th and 7th;
- Due to Verizon conversion, public works employee phones upgraded resulting in enhanced cross department communication, infrastructure monitoring, and department-wide calendar scheduling;
- Police Department purchased 2010 Crown Victoria from Kansas Highway Patrol to replace wrecked cruiser;
- Library received \$5,500 grant to aid foundation repair and electrical upgrades at Library;
- Roof leaks at library were discovered due to needed tuck pointing and clogged gutters trees removed on South Side of Library;
- Foundation repair, tuck pointing, and landscaping/drainage improvements completed at Library;
- Additional HVAC unit installed at Library;
- Library installed new carpet;
- City-wide clean-up days held in May very successful event;
- Extremely productive tire collection held in August;
- Replaced engine in a Parks Department Mower;
- Replaced engine in Fire Department Unit 60 Equipment Truck;
- Annual sewer maintenance program completed including tree root treatment;
- New Wastewater Treatment Facility brought online in April, old plant retrofitted for secondary treatment and storage brought online and dedicated July 1, 2013;
- Sewer line repairs completed by Beckenhauer Construction/O'Hara Plumbing on 6th Street line between Fairview and South Streets;
- 50 Building Permits issued in 2013 at estimated total value of \$10,433,996;
- 9 Demolition Permits submitted in 2013.
